I acknowledge and agree to accept the following terms and conditions based on which the access to the BOSS is provided to the Users. I agree that these terms are in addition to and not in derogation of the terms and conditions of the Member Client agreement entered with you.

- I, the User, am a current legal Internet user / have access to the Internet and have knowledge of how internet works.
- Upon the User's request and subject to the eligibility criteria, KCSPL shall provide access to the BOSS through Internet.
- The User agrees and acknowledges that the data accessed from the BOSS facility provides information only for the purpose of user information and client servicing.
- The User shall not attempt or permit others to attempt accessing the account information stored in the computers of KCSPL which does not relate to my account and/or for illegal or improper purposes.
- The User shall comply with operational instructions as given by KCSPL for operating the BOSS facility.
- Upon approval of the permission to access BOSS facility, KCSPL shall allot a user name and password to me.
- The User shall be solely responsible for maintaining secrecy of the password so provided and KCSPL is in no way responsible for the misuse of the said password by any person other than the authorised user.
- KCSPL does not assume any responsibility in this behalf including loss incurred by the User as a result of misuse / unauthorized use of User ID / Password.
- In case the User forgets the password, a new password shall be provided ONLY on written request by the User.
- The information that is accessed through the BOSS facility shall not be used for the purpose of any claim with any authority or to institute litigation or resolve disputes of any matter.
- The user shall indemnify and hold KCSPL harmless against all actions, claims, demands, proceedings, losses, damages, costs, charges and the expenses whatsoever which KCSPL may at any time incur, sustain, suffer or be put to as a consequence of or by reason of arising out of providing access to BOSS facility.
- The user acknowledges that the software underlying the BOSS facility is the legal property of KCSPL. The access given by KCSPL does not convey or confer any proprietary or ownership rights in the said software. The user shall in no way try to alter / tamper or experiment with the said programme. Any breach on the part of User will be dealt under the appropriate law and User shall be liable for damages that may be incurred by KCSPL.

The User shall not attempt to modify, translate, disassemble, decompile or reverse engineer the software underlying the BOSS facility or create any derivative product based on the software.
